### Stewardship

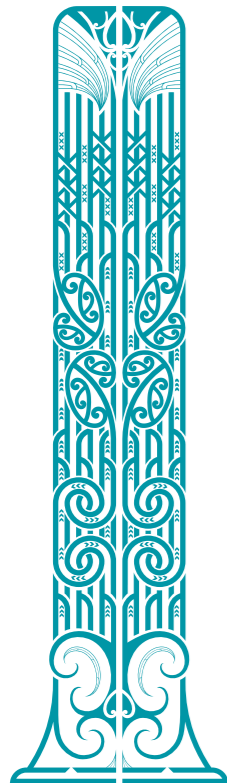
Actively making sure what we're responsible for is fit for purpose today and tomorrow
