1. I refer to your Official Information Act request dated 28 January 2024 in which you asked that Crown Law identify, and/or provide additional details on an already identified, government strategy document. The full text of your request is reproduced at the end of this letter.
2. You asked for the information to be released to you by way of update to an Excel workbook provided, in which you had already identified the *Te Rautaki Ratonga Ā-Ture A Te Kāwanatanga Government Legal Services Strategy 2022-2026* as being in scope of your request. You requested that Crown Law provide further information on this document, and on any other documents that fall within scope of your request.
3. We have decided not to provide further information on the Government Legal Services Strategy 2022-2026, as it does not fall within the scope of your request. In your request, you have excluded any strategy documents “only made public as the result of an OIA request”.
4. The publication of the Government Legal Services Strategy 2022 – 2026 was only made as a result of an OIA request received by Crown Law in December 2022.

Thank you for your email of 28 January 2024 to the Department of Corrections – Ara Poutama Aotearoa, requesting information on Government Department Strategies (GDS). Your request has been considered under the Official Information Act 1982 (OIA).

You requested:

*The purpose of this OIA is to create an accurate list of GDSs in operation as at 31 December 2023. In order to achieve this, we would like to ask you the following three questions summarised below, but specified in more detail in the Excel attached. The Excel notes by row, (i) all existing GDSs in 31 December 2021 (in blue) or (ii) possible GDSs (in green), found by my team. Our preference is that you answer the questions in the Excel, and email the Excel back to us.*

- 1. Are the existing GDSs (as at 31 December 2021) still active?*
- 2. Are there any GDSs that are missing from the attached document? If yes please add to the Excel document attached.*
- 3. Are there any GDSs that are included in the attached document that have been recently archived (and therefore need to be removed from our list)?*

Please see the completed excel spreadsheet with updated information on Corrections' GDS' as requested.

Please note that an external link to the National Historic Heritage Strategy 2013 does not exist or cannot be found. We have attempted to confirm that an external website has is available for this strategy by contacting the relevant parties, however, they have confirmed they believe no such weblink exists. Therefore, this part of your request is refused under section 18(e) of the OIA, as the link to the information requested does not exist or cannot be found.

As per section 18B of the OIA, we have considered whether consulting with you would enable the request to be made in a form that would remove the reason for the refusal. However, we do not consider that the request can be refined in this instance.

Additionally, while the National Historic Heritage Strategy 2013 appears to remain active, we believe this strategy falls outside of the scope of the request as it is not considered a strategy which materially affects the outcomes of Corrections or is linked to any budget initiative and does not meet all of the seven requirements provided by you as a requisite of being a GDS.

Please note that this response may be published on Corrections' website. Typically, responses are published quarterly, or as otherwise determined. Your personal information including name and contact details will be removed for publication.

I trust the information provided is of assistance. I encourage you to raise any concerns about this response with Corrections. 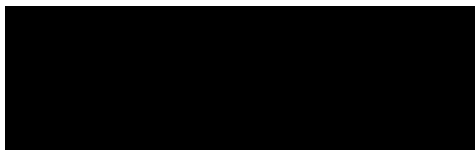

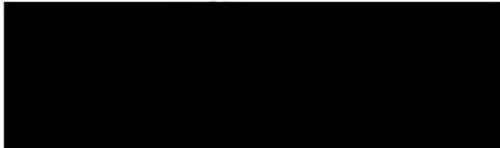

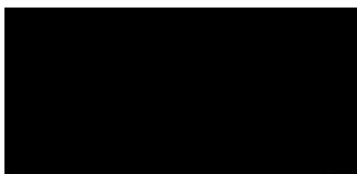

## APPENDIX ONE

### **Te Mahere Whai Mahi Wāhine Women's Employment Action Plan**

#### **Purpose**

Te Mahere Whai Mahi Wāhine Women's Employment Action Plan provides a roadmap of actions towards a better future for women's employment.

Its purpose is to improve the employment pathways for women who are marginalised in the labour market, particularly wāhine Māori, Pacific women, young and older women, disabled women, women who are former refugees and recent migrants, and LGBTQIA+. The plan seeks to address the inequitable outcomes between Māori and non-Māori and increase opportunities for wāhine Māori to maximise their potential and improve their financial security through participation in employment and training. The Plan is guided by Te Tiriti o Waitangi and te ao Māori values.

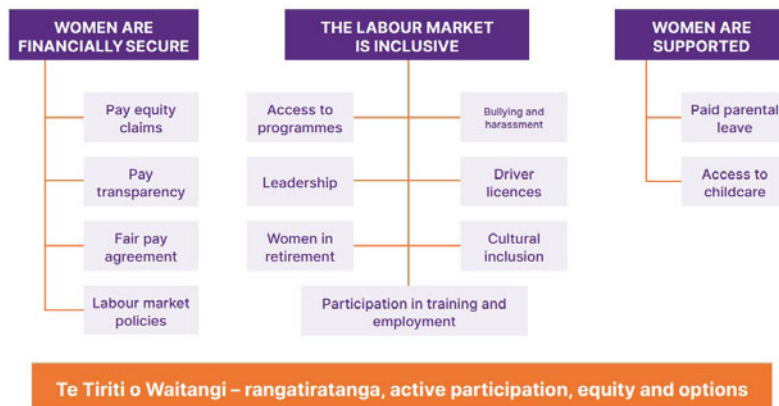
#### **Why develop Te Mahere Whai Mahi Wāhine Women's Employment Action Plan**

Women are still facing critical employment issues in the labour market in Aotearoa New Zealand: They interact differently with the labour market to men, which can put women at an economic disadvantage, and continue to face greater barriers to accessing employment gains in the workplace. Women often earn less than men, even when they have the same qualifications, continue to experience a gender pay gap, are more likely to be concentrated in lower skilled, lower paid, and/or part-time or casual work, often seeking more working hours or working non-standard hours, are involved in insecure or limited employment conditions, making them more vulnerable to job losses, are more likely than men to have experienced discrimination, harassment, or bullying at work, undertake a disproportionate share of caring and family responsibilities, which reduces their capacity to adapt to labour market requirements and changes (this is particularly the case for wāhine Māori and Pacific women), and will be affected by increasing digitalisation and automation.

#### **Te Mahere Whai Mahi Wāhine is structured across three success areas:**

1. Women are financially secure.
2. The labour market is inclusive.
3. Women are supported to meet their paid and unpaid work commitments without incurring penalties.

### Key success areas for the plan:



### This is a cross government agency plan

Te Mahere Whai Mahi Wāhine builds on existing supports for women’s employment. The plan has 31 action items led across the government sector and grouped by success area and timeline. The Plan is a five year plan with immediate, medium and longer term actions to support women’s employment.

Manatū Wāhine Ministry for Women directly leads six actions. It supports action for women within the other six employment action plans: Te Mahere Whai Mahi Māori: Māori Employment Action Plan, Older Workers Employment Action Plan, Former Refugees, Recent Migrants, and Ethnic Communities Employment Action Plan, the Pacific Employment Action Plan, Work Matters – Employment Action Plan for people disabled people, and Youth Employment Action Plan.

### The plan engaged directly with women

The Action plan was developed by communities of women, women's organisations and partner agencies. The Minister for Women's advisory group, the National Advisory Council on the Employment of Women (NACEW), led the engagement to develop the action plan. The Ministry for Women supported this engagement with a series of on line and in person hui as well as sought written advice and input into the plans development. The Action Plan and supporting material is published on the Ministry's website <https://www.women.govt.nz/library/te-mahere-whai-mahi-wahine-engagement-2022>.

### Implementing the Plan

The Plan is a living document. The majority of actions involve a monitoring role of other agency’s initiatives. Successful implementation of the plan requires regular communication and coordination with these agencies. Key indicators of success are measured in completed projects and identifying new and forward actions to support women’s employment. It has a monitoring dashboard reported on 6 monthly to the monitoring agency, the Ministry of Business Innovation and Employment.

Exporting firms are more productive, employ more staff and pay better wages. A strong tradeable sector can therefore help drive our economic recovery and raise living standards.

## Background

---

**T**he government launched the Trade Recovery Strategy in June 2020 at a time when the longevity and course of the pandemic and

associated border restrictions were unknown. The Strategy sought to put Aotearoa New Zealand in the best possible position for recovery.

In 2022, with Aotearoa New Zealand's borders re-opening, the Trade Recovery Strategy 2.0 adjusts our approach to make the most of reconnecting New Zealand. From a trade, economic, education and tourism perspective New Zealand is now fully open for business. The government is focused on supporting businesses as they reconnect with partners, customers and key markets overseas.

At the same time, we recognise that export sectors and businesses have been impacted unevenly by the disruption of the pandemic and border measures, and that recovery will not be 'one size fits all.' Particular attention is needed for an inclusive recovery.

The Trade Recovery Strategy 2.0 also comes at a time of growing risk, uncertainty and pressure in the global economic and trade environment. Building agility and resilience into Aotearoa New Zealand's trade is now more important than ever.

## Trade Recovery Strategy 2.0

**T**o respond to this new reality, the government's refreshed Trade Recovery Strategy (2.0) focuses on four key areas under a 'STAR' organising framework:

- **Sustainable and inclusive trade:** fully supporting the [Trade for All agenda](#) to deliver for all New Zealanders, and contribute to addressing global challenges.
- **Trade and export lift:** lifting the capability of New Zealand's exporters, and directly supporting kiwi businesses in their markets, including through trade missions and economic diplomacy.
- **Architecture:** Free Trade Agreements, other trade agreements, and global organisations such as the World Trade Organisation provide the architecture within which businesses can trade under predictable rules. The government will continue to invest in building this architecture, both through the [negotiation of new agreements](#), and implementation of

those agreements already concluded, as well as progressing New Zealand's priorities through the World Trade Organisation, Organisation for Economic Cooperation and Development, and Asia Pacific Economic Co-operation etc.

- **Resilience:** addressing vulnerabilities exposed or exacerbated by the pandemic, and strengthening New Zealand's trade against future shocks. This includes promoting diversification of trade, mitigating supply chain pressures, and working with other cross-government economic strategies, particularly for emissions reduction.

These four areas are all inter-related and continue to be underpinned by the Trade for All agenda. They will be delivered through the coordinated action of the eleven agencies that make up the Trade Recovery Strategy interagency group:



**B**y setting us on the right path, the Trade Recovery Strategy 2.0 also complements and supports longer-term government work programmes for economic transformation led by some of these agencies, such as:

- Emissions Reduction Plan
- Industry Transformation Plans
- New Zealand Freight and Supply Chain Strategy

We have excluded the four associated agency's listed on the Te Puna Aonui website, found here. However, for the purposes of the 'Draft Master Excel', we have treated the eight departments (that form part of the executive board) as 'jointly holding' the GDS (with the exception of New Zealand Police, as they are not a department). If you disagree with this treatment, please let us know.*

Thank you for your email. Confirming the information in the red rows are correct. The business unit has made minor updates to columns F, G, H and I in row 35 and 51 on the attached spreadsheet.

To note, Ministry of Health is the department responsible for preparing the integrated problem gambling strategy specified in the Gambling Act (s317-320 refers). The Act requires the cost of the strategy activities to be recovered by a levy and these costings must be updated every three years. The Act also specifies a number of statutory requirements to be fulfilled to update these costs, which in practical terms results in a revised strategy being prepared and published every three years. Currently the Strategy to Prevent and Minimise Gambling Harm 2025/26 to 2027/28 is under development and once approved will come into effect on 1 July next year, and replace the Strategy to Prevent and Minimise Gambling Harm 2022/23 to 2024/25 that came into effect on 1 July 2022 and will lapse on 30 June 2025.

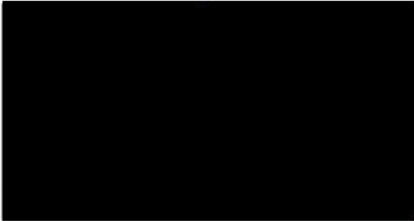

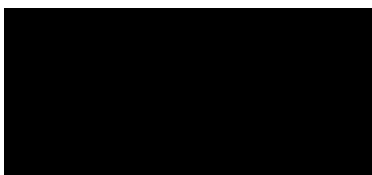

Thank you for your further questions. Please see responses below.

New Zealand Search and Rescue Strategic Plan 2021-2024 was published in 2021.

We would not consider the Decarbonising Transport Action Plan 2022–25 as jointly held with Ministry for the Environment as all the content falls within the transport portfolio. We noted in our response that we do not consider it to be a GDS however after reconsidering the criteria, we agree that the Decarbonising Transport Action Plan does contain both the ‘means’ and the ‘ends’, so could be considered a GDS. 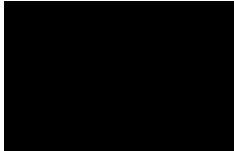

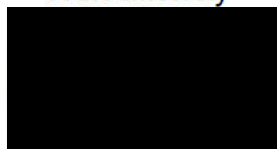

- Not a statement of intent or annual report.



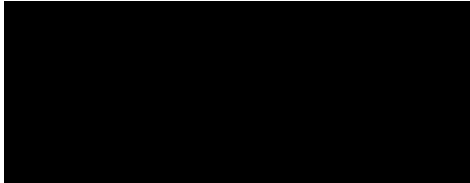
